



## **2010 Continuing Education Scholarship Competition Rules and Application Instructions**

---

### **Awards**

---

Belvoir Federal Credit Union will award a \$1,000.00 scholarship to a student currently enrolled in higher education. Decision is made by a Belvoir Federal Scholarship Selection Committee. All decisions are final.

### **Eligibility**

---

Applicant must:

- be a member of Belvoir Federal
- have joined Belvoir Federal by September 30, 2009
- be the primary member of their own account (not just a joint owner on someone else's account). Applicant's account must be in good standing
- be a college student (rising sophomore, junior, or senior) at an accredited college or university, taking at least nine (9) credit hours per semester for the 2010-2011 academic year. Applicant may be in an undergraduate program or in an associate's degree program at a community college. Graduate students are not eligible
- Belvoir Federal employees, directors, committee members, other volunteers and their families are not eligible. Previous scholarship winners are not eligible

### **Materials to submit for considerations**

---

1. A 350-500 word essay, typed and double-spaced on the following topic: **“Explain the value of credit union membership and why doing business with a credit union is important”**. Do not use your name in the essay or put it on the essay page.
2. Letter of character reference from a favorite teacher, someone in the community or college advisor.
3. Completed Belvoir Federal Credit Union Scholarship Application.
